



PROFESSIONAL LICENCING EVALUATION FORM

Top Fuel - Top Fuel Funny Car

All competitors must present to IHRA Australia Tech Staff, prior to Licencing. A formal request in writing to Head Office NO later than 7 days prior to commencement of First Stage of Licencing.

Licencing must be conducted at an IHRA Australia Facility.

Licencing must be contested over two separate days.

Licencing may not be completed at a Major Event or National Points round.

Testing Panel will consists of the IHRA Australia Chief Steward or an assigned Steward and current class licenced driver.

The IHRA Chief Steward or the IHRA Steward will endorse the licence accordingly at the successful completion of Licence Testing requirements as listed below.

PROCEDURE (solo passes) New Driver / Class Upgrade

- Blindfold Test
- 2 x Burnout / Launch 330ft shut down
- 2 x 660ft (1/2 Track) passes under power (class representative time) - shutdown - chutes deployed

The completion of one of the following:

- 1 2 x Full track passes (All runs under power and within (4 tenths of the current National Record) to the satisfaction of the Testing Panel, for Drivers currently licenced in one of the following;
 - A) Pro Alcohol Dragster and licencing for Top Fuel and having a minimum of two (2) years experience approved by IHRA Australia; or
 - B) Pro Alcohol Nitro Injected Dragster and licencing for Top Fuel and having a minimum of two (2) years experience approved by IHRA Australia: or
 - C) Pro Alcohol Funny Car / Altered and licencing for Top Fuel and having a minimum of two (2) years experience approved by IHRA Australia; or
 - D) 2 x Full track passes completed to the satisfaction of the Testing Panel, for Drivers that have completed the relevant course at an IHRA recognised Drag Racing Driving School; or
 - E) 3 x Full track passes (all runs under power and within (4 tenths of the current National Record) to the satisfaction of the Testing Panel.

All passes must meet the satisfaction of the Testing Panel.

FAMILIARISATION PASSES (solo passes)

Any competitor who has not performed a minimum of one full pass (class nominated) within the previous two year period, then the competitor must complete:

- 1 x 660 (1/2 Track) pass under power (class representative time) - shutdown - chutes deployed
- Top Fuel 1 x Full track pass 1000ft (all runs under power and within 4 tenths of the current National Record)
- Top Fuel Funny Car 1 x Full track pass 1320ft (All runs under power and within 4 tenths of the current National Record)

Testing Panel will consists of the IHRA Australia Chief Steward or an assigned Steward and current class licenced driver.

Both passes must meet the satisfaction of the Testing Panel
